Mathematical Model for Schistosomiasis Transmission Dynamics and Optimal Control in Uganda

ABSTRACT

Schistosomiasis, a parasitic disease spread by snails, is a major health and economic issue in tropical and sub-tropical areas, particularly in Pakwach District, Northern Uganda, where it significantly affects both humans and cattle. This study aims to develop a mathematical model to understand the transmission dynamics of schistosomiasis, with a focus on the role of varied intermediate hosts in the region. The model uses nonlinear differential equations and includes human, animal, and snail populations to explore the effectiveness of control measures like mass drug administration, snail control, and public health education. Key findings highlight that controlling the environment where infected snails thrive is crucial, and public health education is especially effective. Limitations include reliance on existing data, and future research should focus on refining the model, vaccine development, and evaluating the cost-effectiveness of control strategies. The study provides valuable insights for schistosomiasis control in Pakwach and similar regions globally.

Keywords: schistosomiasis, transmission, dynamics, Pakwach district and optimal control.

1.0 INTRODUCTION

Schistosomiasis, a disease caused by parasitic worms from the Schistosoma genus, remains a major public health concern worldwide, especially in tropical and subtropical areas. Sub-Saharan Africa is hit hardest, with the disease having a profound effect on both health and economic development (World Health Organization [WHO], 2023). Despite efforts to control it over the years, transmission continues due to the intricate interactions between the parasite, freshwater snails that serve as intermediate hosts, and humans (Vaughan et al., 2022). Snails from the Biomphalaria and Bulinus genera are essential to the spread of the disease (Ayoubi et al., 2022). Factors like snail population density, age, and how easily they get infected complicate efforts to model and control the transmission (Gauthier et al., 2023). Tackling these complexities is crucial for improving our understanding of how the disease spreads and for refining control measures (Sousa et al., 2021).

The transmission cycle of schistosomiasis has several stages. It begins when eggs from adult worms in human hosts hatch in water, releasing miracidia that infect snails. Inside the snails, the parasites develop and are later released as cercariae, which can penetrate human skin when people come into contact with contaminated water (Vaughan et al., 2022). Schistosomiasis affects more than 240 million people across 78 countries, causing serious health issues such as anemia, malnutrition, and stunted growth and cognitive development in children. The disease also results in substantial economic losses due to decreased productivity and higher healthcare costs (WHO, 2023).

Several studies have used mathematical models to explore different aspects of schistosomiasis transmission and control. Zhang and Zhao (2020) investigated how seasonal changes and water temperature impact parasite development, suggesting eradication is possible if the basic reproduction number (R₀) is below 1, though they didn't include animal populations or environmental factors. Anderson et al. (2021) highlighted the importance of snail age structure in influencing human infection

rates, but their model didn't consider environmental or control factors. Madubueze et al. (2022) focused on acute and chronic human infections, emphasizing the role of snail death rates and parasite decay, without exploring specific control strategies. Kadaleka et al. (2022) incorporated both human and animal hosts and found molluscicides to be highly effective, though they did not examine detailed intervention strategies. Kalinda et al. (2019) applied optimal control theory and showed that lowcost strategies could significantly reduce human infections, but did not consider vector control or migration. Finally, Ding et al. (2017) included an exposed compartment for the disease's incubation period, but did not account for animal populations or a contaminated environment. These studies highlight the complexity of modeling schistosomiasis and underscore the need for more comprehensive models that integrate ecological, environmental, and control factors for better disease management.2001).

The Mathematical Model

A model of schistosomiasis is developed using a deterministic compartmental modeling approach. At any given time t, the total human population denoted by $N_h(t)$ is divided into three subgroups consist of the following classes: susceptible human

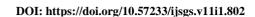
 \boldsymbol{S}_h , exposed human \boldsymbol{E}_h and infected human \boldsymbol{I}_h . Hence,

Similarly, the total snail population denoted by $N_{_{\boldsymbol{\nu}}}(t)$ is divided into three subgroups consist of the following classes: susceptible snail $S_{_{\boldsymbol{\nu}}}$, exposed snail $E_{_{\boldsymbol{\nu}}}$ and infected snail $I_{_{\boldsymbol{\nu}}}$. Hence,

Also, the schistosome population denoted by N_c is the concentration of Miracidia and Cercariae in the contaminated water.

The schistosomiasis model uses a deterministic compartmental approach to describe disease transmission among humans, snails, animals, and the contaminated environment. Each population—humans, snails, and animals—is divided into susceptible, exposed, and infected classes. Individuals move between these classes based on recruitment, infection through contact with contaminated water, progression of the disease, and natural or disease-related death. The aquatic environment becomes contaminated with schistosome parasites (miracidia and cercariae) through contributions from infected humans, snails, and animals. The parasite concentration in water drives new infections across all populations. This model captures the dynamics of transmission and highlights key points for intervention and disease control.

The above description culminates into the following system of differential equations

Disease-free equilibrium points (DFE) are steady-state solutions where there is no disease (schistosomiasis). We define the "diseased" classes as the human, Snail or Animal populations and the Water body that are either exposed, or infected, that is;

The basic reproduction number can be utilized to assess the local stability of the disease-free equilibrium point.

Sensitivity Analysis of Model Parameters

Understanding the key factors driving disease transmission is essential for reducing human and animal fatalities and alleviating suffering. The transmission dynamics of the disease are primarily governed by the basic reproduction number (\Re_0) (Amiru &

Abdullahi, 2022). By analyzing the sensitivity of model parameters in relation \mathfrak{R}_0 , the most influential factors in disease spread can be identified. Modifying these parameters can help control transmission, either by mitigating or amplifying disease spread. This sensitivity analysis is crucial for experimental design, data assimilation, and simplifying complex nonlinear models (Abdullahi & Amiru, 2023a). Table 2 provides a detailed description of the parameters used in the schistosomiasis model.

The sensitivity analysis identifies key factors influencing the spread of schistosomiasis. The most critical factor is the rate of water deterioration, with a strong negative sensitivity index (-1.00), indicating that poor water quality disrupts the parasite's life cycle by affecting infected snails. Highly sensitive factors (sensitivity > 0.5) include human exposure to contaminated water (0.54) and snail population dynamics (0.51), suggesting that improving sanitation, reducing water contamination, and controlling snails can significantly curb transmission. Moderately sensitive factors (sensitivity between 0.17 and 0.46) such as snail reproduction rates and secondary host interactions also influence transmission but are less critical. Low sensitivity parameters (sensitivity < 0.1), including the natural mortality rates of humans and snails, have minimal effect on disease spread. One parameter shows an almost negligible impact (0.000002), indicating it is irrelevant for intervention efforts.

Implications for Schistosomiasis Control

To effectively reduce schistosomiasis cases, control efforts should focus on the most highly sensitive parameters. This includes increasing Rate of deterioration of water (-1.00), reducing human exposure to contaminated water (0.54), and managing snail populations (0.51). Environmental factors (0.46 - 0.17) should be addressed as supportive measures, but low-sensitivity parameters should not be a priority, as they have minimal impact.

Optimal Model Formulation

To effectively control schistosomiasis, time-dependent strategies are considered based on sensitivity analysis. These include mass drug administration to reduce human infections, snail control to target the parasite's intermediate host, and public health education with improved sanitation to prevent transmission and promote healthy behaviors. Susceptible humans and animals get infected

following their contact with Cercariae parasite in the water at a rate $(1-u_3)\beta_1C_eS_h$ and $(1-u_3)\beta_1C_eS_a$, $u_3(0 \le u_3 \le 1)$

is the control on the use of Public Health Education. The treatment of both humans and animals $u_1 (0 \le u_1 \le 1)$ is the use of the

Mass Drug Administration (MDA). Susceptible snails $\left(S_{_{V}}\right)$ get infected following effective contacts Miracidia – parasite egg stage

Subsequently, the numerical solutions of the optimality system and the corresponding optimal control pair, the parameter choices, and the interpretations from various cases are discussed.

Numerical analysis

This section analyzes the impact of optimal control strategies on schistosomiasis using a numerical approach. The model solves state and adjoint equations iteratively with the Runge-Kutta method, updating control strategies until results converge. Four strategies are tested: combining two controls at a time—Mass Drug Administration, Snail Control, and Public Health Education—and finally applying all three together to evaluate their effectiveness in reducing disease transmission. For the numerical simulation

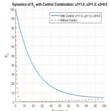
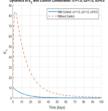


Figure 1: effect of the control strategy A on susceptible humans

Figure 2: effect of the control strategy A on expose humans

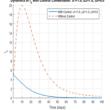


Figure 3: effect of the control strategy A on infected humans

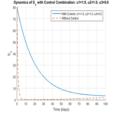


Figure 4: effect of the control strategy A on susceptible Animals

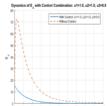


Figure 5: effect of the control strategy A on exposed Animals

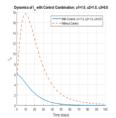


Figure 6: effect of the control strategy A on infected Animals

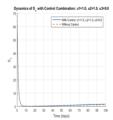


Figure 7 : effect of the control strategy A on Susceptible Snails

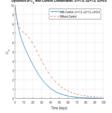


Figure 8 effect of the control strategy A on

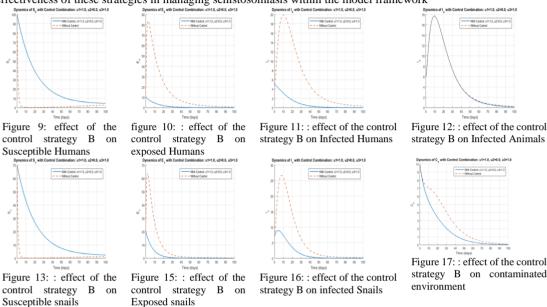

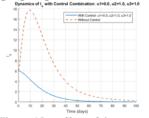


Figure 18: : effect of the control strategy C on Infected Animals

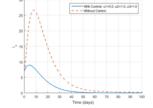


Figure 19: : effect of the control strategy C on Infected snails

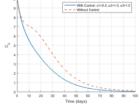


Figure 20: : effect of the control strategy C on contaminated environment

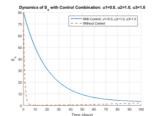


Figure 21: : effect of the control strategy C on susceptible Animals

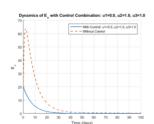


Figure 22: : effect of the control strategy C on exposed snails

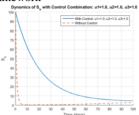


Figure 24: effect of the control strategy D on Susceptible Humans

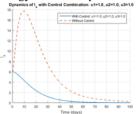


Figure 27: effect of the control strategy D on infected Animals

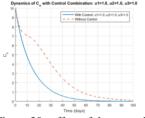


Figure 30 : effect of the control strategy D on contaminated environment

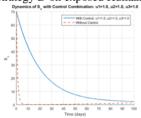
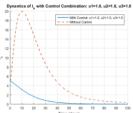


Figure 28: effect of the control strategy D on Susceptible snails

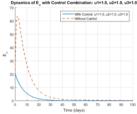


Figure 29 : effect of the control strategy D on exposed snails

Numerical Analysis and Optimal Control Strategies

Numerical simulations showed that combining control measures is effective in reducing schistosomiasis. Strategies involving two interventions—such as drug administration, snail control, or public health education—reduced infection rates, but the most significant impact was achieved when all three were used together. This highlights the importance of a comprehensive approach, and the model helps evaluate the cost-effectiveness of each strategy for better resource planning.

CONCLUSION

This study developed a mathematical model to understand the transmission dynamics of schistosomiasis in Pakwach District, Northern Uganda, focusing on the role of freshwater snails as intermediate hosts. The model showed that managing both snail populations and environmental factors, such as water sanitation, along with public health education, could significantly reduce disease transmission. An integrated approach combining mass drug administration (MDA), snail control, and education was identified as the most effective strategy. However, the model's reliance on existing literature rather than local data is a limitation. Future research could refine the model with real-world data, explore vaccine development, and assess the cost-effectiveness of control strategies. The study offers valuable insights for policymakers, providing a framework for targeted

interventions, and has broader applications in public health planning, vector control, and global health initiatives.
