ABSTRACT

The integration of Artificial Intelligence (AI) in healthcare has shown significant potential in changing the world of medicine by improving diagnostic accuracy, personalizing treatment plans, and enhancing patient care. This comprehensive review explores the most prominent AI applications emerging within the healthcare sector, focusing on their contributions, challenges, and future prospects. Key applications, including machine learning (ML), natural language processing (NLP), and robotics, are examined in the context of clinical decision support, medical imaging, drug discovery, personalized medicine, and robotic surgery. The use of AI-driven tools such as predictive analytics, intelligent diagnostic systems, and virtual assistants is revolutionizing disease prevention, early detection, and patient monitoring. Additionally, the role of AI in operational efficiency, such as optimizing hospital workflows and automating administrative tasks, is discussed. Despite the promising advancements, the review also highlights the ethical concerns, data privacy issues, and the need for robust validation frameworks to ensure the safe and equitable implementation of AI technologies in healthcare. The paper concludes with a look into the future, proposing directions for further research to harness AI's full potential in transforming healthcare delivery and improving health outcomes globally.

1.0 INTRODUCTION

Healthcare as a whole has recently seen profound changes, driven by swift technological advances and increased demand for high-quality patient care. Among the many promising technologies to emerge in this space is Artificial Intelligence, with an option to transform how healthcare is delivered, managed, and experienced. Artificial Intelligence (AI) refers to the development of computer systems that can perform tasks that typically require human intelligence, such as learning, problem-solving, and decision-making (Wiens et al, 2023). Several studies by McKinney *et al.* (2023), Rajpurkar *et al.* (2023), Ardila et al, (2023), Liu *et al.* (2024), Chen *et al.*, (2019), Liang *et al.* (2019), Santana *et al.* (2019), and Tucker *et al.* (2019) have reported AI application in a variety of healthcare domains, such as diagnosis, treatment, consultation with patient, and management of public health. While the idea of using AI to support healthcare is not new, it has recently gained significant momentum due to advances in computer vision, machine learning, and natural language processing. These technical breakthroughs have made it possible to create AI-powered systems capable of analysing huge volume of data, identifying trends, and producing recommendations or projections (Chen *et al.*, 2019).

Despite the many potential benefits of AI application within healthcare, there are still a number of obstacles and restrictions to the use of AI within healthcare that

must be overcome. The absence of standardisation and regulation in the creation and implementation of AI-powered systems is a major barrier (He *et al.*, 2019). This may result in variations in the safety and performance of AI-powered devices, which could endanger patients. Another difficulty is finding high-quality data to validate and train AI-powered systems (Chen *et al.*, 2019). This may prove challenging for healthcare organisations since data is frequently fragmented, incomplete, and of varying quality.

To overcome these barriers, more funding must be allocated to AI advancements, and stricter regulation and supervision of AI-powered systems will be required (He *et al.*, 2019). Additionally, more transparency and explainability are required in AI decision-making, to guarantee that physicians and patients understand how AI-powered systems are making recommendations or predictions (Zou et al., 2023). Lastly, additional education and training on AI and machine learning are required to guarantee that healthcare professionals possess the skills and knowledge required to effectively deploy and use AI-powered systems (Chen *et al.*, 2019). If these obstacles and restrictions are overcome, AI will provide the ability to completely transform the healthcare sector.

2.0 THEORETICAL FRAMEWORK

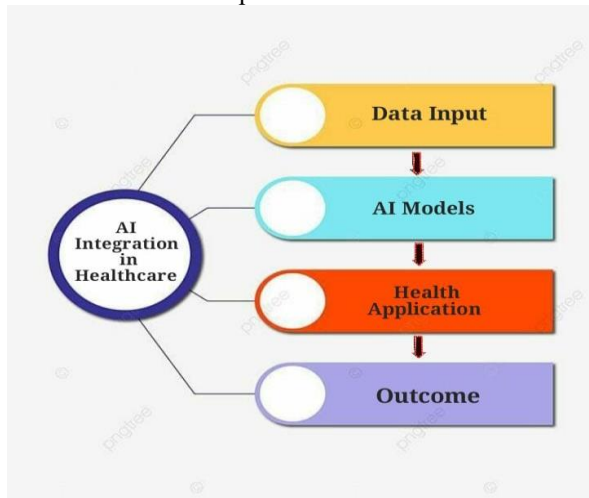


Figure 1: Framework for AI integration in Healthcare

Figure 1 shows a visual summary of the theoretical framework of AI Integration in Healthcare, illustrating the flow from Data Input to Outcomes.

This framework highlights the interconnected components of AI integration in healthcare: from Data Input (such as Electronic Health Records, wearable devices, and medical imaging) to AI Models (Machine Learning, Natural Language Processing, and Robotics), then flowing into Healthcare Applications (such as predictive analytics, clinical decision support, and robotic surgery), and finally, leading to Outcomes like improved patient care, operational efficiency, and healthcare scalability. The components of the framework — Data Input, AI Models, Healthcare Applications, and Outcomes — are key to understanding how artificial intelligence is transforming the healthcare landscape. This framework is a useful visual tool for illustrating how data and AI intersect to improve patient care, medical decision-making, and overall healthcare efficiency.

Numerous studies have explored the framework for AI integration in Healthcare, investigating both its benefits and challenges. Key works include Cohen *et al.*, (202), which reviews the history, current state, and future of AI applications within healthcare; Oermann *et al.*, (2019), which highlights AI's transformative role within diagnostic imaging while addressing concerns over regulations and ethics; Abd-Alrazaq *et al.*, (2019), which explores machine learning's potential in making medical decisions and its associated ethical and regulatory challenges; Capan *et al.*, (2019), which analyzes the ethical and societal ramifications of artificial intelligence, highlighting concerns about accountability, bias, and transparency; and Srinivasa *et al.*, (2018) which discusses the present position, benefits, along with difficulties of robotic-assisted surgery, including ethical and legal concerns. Other notable works includes McKinney *et al.*, (2023) and Rajpurkar *et al.*, (2023), which investigated the

application of AI-driven algorithms to accurately diagnose breast cancer and diabetes respectively. Zou *et al.*, (2023) developed an AI-powered system that predicts how well patients will respond to treatment for depression, in order to create a more individualized treatment plan while Tucker *et al.*, (2019) and Santana *et al.*, (2019) investigated how chatbots and virtual assistants driven by AI can enhance consultation with patients, patient compliance with medication, and disease management. Collectively, these studies underscore AI's outstanding promise in healthcare while emphasizing the need to address ethical and regulatory concerns to ensure its safe and successful deployment.

However, several critical gaps in the literature hinder its widespread adoption and effectiveness. One major issue is the lack of generalizability and inherent biases in AI models, which are often trained on limited or non-diverse datasets (Chen *et al.*, 2019). This leads to reduced accuracy when applied to underrepresented populations, such as ethnic minorities or patients with rare diseases, and poor performance in real-world clinical settings outside controlled research environments. Another key challenge is the explainability and trustworthiness of AI systems, particularly with complex models like deep learning. Many AI tools operate as "black boxes," making it difficult for clinicians to interpret and trust their recommendations, thereby limiting their practical utility. Additionally, there is a notable research gap in AI's seamless integration with clinical workflows, as many AI solutions function in isolation rather than being embedded within electronic health records (EHRs) or hospital systems. Few studies explore the long-term usability of AI tools or the barriers to clinician adoption. Ethical and legal concerns further complicate AI deployment, including unresolved questions about liability in case of errors, lack of standardized regulatory frameworks, and risks to patient data privacy and security. While AI has shown promise in diagnostics, there is limited research on its role in preventive and personalized medicine, particularly in behavioural health interventions and chronic disease management. Future research should prioritize real-world validation, ethical AI deployment, and seamless integration into healthcare systems to fully harness AI's transformative potential.

3.0 VARIOUS COMPONENTS AND STAGES OF AI INTEGRATION INTO HEALTHCARE

3.1 Data Input and Collection

AI's journey in healthcare begins with data input and collection, which forms the foundation for all AI applications. Data input includes several categories such as:

- i. Electronic Health Records (EHRs): EHRs serve as a major source of structured and unstructured patient data, including patient demographics,



- medical history, diagnoses, medications, and lab results (Singhal *et al.*, 2024).
- ii. **Medical Imaging:** Medical imaging includes CT scans, MRIs, X-rays, and ultrasound images. AI models, particularly deep learning models, analyze these images to detect anomalies such as tumors, fractures, and diseases like pneumonia or cancer (Rajpurkar *et al.*, 2020).
 - iii. **Wearable Devices and IoT:** Devices like smartwatches, sensors, and wearable health monitors provide real-time data, such as heart rate, activity levels, and sleep patterns, all of which can be fed into AI systems for continuous monitoring and predictive analytics (Topol, 2019).
 - iv. **Genomic Data:** AI uses genomic data to personalize treatment plans by identifying genetic markers associated with diseases, thus supporting precision medicine (Beam *et al.*, 2024).

Data Quality Management: To make sense of the vast amount of data, AI models require high-quality, preprocessed data. This involves data cleaning, normalization, and error detection to ensure the reliability of inputs. Proper data management ensures that AI models function effectively.

3.2 AI Models (Machine Learning, Natural Language Processing, and Robotics)

AI in healthcare is driven by several advanced models and techniques that are designed to handle different types of data and healthcare tasks:

Machine Learning (ML)

Machine learning, a component of AI, enables computers extract information from data without requiring explicit programming (Ramalingam *et al.*, 2023). It can be used for a variety of healthcare tasks, including image analysis, medical evaluation, and planning for therapy. For instance, machine learning systems can investigate clinical imaging such as MRI scans to detect patterns and forecast outcomes. Additionally, they can create forecasting algorithms that will track disease progression and assess treatment effectiveness. By leveraging its capacity for recognizing trends and making data-driven predictions, machine learning has significantly transformed areas like image analysis, clinical evaluation, and therapeutic planning in healthcare, demonstrating a great future for improving the health of patients.

In the diagnostic imaging field, machine learning systems are being built for processing and analysing clinical pictures from a variety of modalities, such as MRI scans, X-rays, and Computerized Tomography scans (Oermann *et al.*, 2019). These algorithms are capable of detecting and classifying abnormalities, tumors, and other medical conditions with remarkable precision. By training on extensive datasets of

annotated imageries, machine learning systems can recognize subtle patterns that might escape human knowledge (Abd-Alrazaq *et al.*, 2019). This capability assists radiologists, and other medical practitioners provide more precise and quick diagnoses, hence improving care for patients. Additionally, forecasting models of illness development and therapeutic outcomes can be developed using algorithms for machine learning. By examining patient data—such as clinical records, genetic information, and biomarkers—these models can uncover patterns and risk factors associated with various illnesses. This insight enables healthcare providers to forecast disease progression, identify patients at greater risk of complications, and customize treatment strategies to improve outcomes.

Machine learning is also used extensively in therapy plan development and decision-making. By analyzing large-scale databases that includes information about patients, medical findings, and clinical recommendations, models for machine learning can provide personalized treatment recommendations suited to specific needs of each patient (Tucker *et al.*, 2019). This capability helps healthcare providers identify the best treatment plans while also improving general care for patients.

Furthermore, models for machine learning hold the ability of revealing new patterns and relationships within biomedical data, providing pathways for ground-breaking discoveries and advancements in medical research. By analysing extensive datasets from genomics, proteomics, and other -omics fields, machine learning can reveal genetic markers, biomarkers, and potential drug targets. This capability can significantly speed up therapeutic innovation and advancement process, enabling the creation of more targeted and personalized therapies. However, machine learning application to healthcare does not occur without challenges. Concerns about confidentiality, data quality and ethics must be carefully addressed (Capan *et al.*, 2019). Additionally, having access to large, diverse datasets and effective collaboration between medical practitioners and data scientists are essential to effectively deploy algorithms for machine learning in medicine.

Natural Language Processing (NLP)

Natural Language Processing (NLP), a subfield of artificial intelligence (AI), empowers computers to comprehend, interpret, and generate human language. This technology has been applied to various healthcare settings, including clinical documentation, consultation with patients, and clinical investigation. For instance, NLP can extract valuable information from clinical notes and health records electronically to enhance clinical decision-making and care for patients. Additionally, chatbots and virtual assistants can be built

with NLP to assist patients in managing their health (Liu *et al.*, 2024).

NLP is of great importance in processing enormous number of textual data generated by healthcare professionals, such as EHRs, clinical notes, and research papers. By analyzing and extracting relevant information from these unstructured texts, NLP algorithms can identify critical clinical details like diagnoses, treatments, and lab results. This capability not only streamlines decision-making but also improves the efficiency of information retrieval, ultimately contributing to better healthcare outcomes.

NLP can also enhance clinical decision-making by offering evidence-based recommendations (Ramalingam *et al.*, 2023). By analyzing medical literature, treatment guidelines, and patient data, NLP algorithms can extract pertinent information and generate insights to help healthcare providers make well-informed decisions. For example, NLP evaluates patient symptoms and medical history to propose potential diagnoses or recommend suitable treatment options using the most recent medical information. Additionally, NLP can enhance the condition of patients by detecting and monitoring adverse events. By examining patient records, the algorithms for NLP can spot trends and anomalies that may indicate medication errors or adverse therapeutic effects, allowing healthcare providers to intervene promptly, thus lowering risks and improving safety for patients.

NLP applications can also greatly enhance consultation with patients. NLP-powered virtual assistants and chatbots can interact with patients, answering their queries, providing educational content, and assisting with appointment scheduling (Santana *et al.*, 2019). These virtual assistants leverage NLP algorithms to understand and respond to natural language inquiries, making interactions more intuitive and efficient. Furthermore, NLP can support clinical research and knowledge discovery by analysing enormous number of published articles. NLP algorithms can extract relevant information, identify trends, and help researchers explore new hypotheses, thereby accelerating the research process and advancing medical knowledge.

However, implementing NLP in healthcare comes with set of challenges. Natural language is inherently complex, ambiguous, and context-dependent, which makes it difficult for computers to accurately comprehend and decode. Variations in language, specialized medical terminology, and the demand for handling private patient information further complicate the application of NLP within healthcare. Developing robust algorithms for NLP that can handle these issues while maintaining high accuracy remains a critical area of ongoing research.

Emergence of Robotics in Healthcare

Robots have been applied to various healthcare domains, encompassing surgery, rehabilitation, and care for patients (Peters and Kwasnicki, 2020). For instance, surgical robots enable minimally invasive procedures, which can shorten recovery periods and enhance patient outcomes (Ramalingam *et al.*, 2023). Additionally, robots facilitate telemedicine by allowing medical professionals to remotely keep an eye on patients and deliver real-time care. Robotics integrates mechanical systems with algorithms for AI to develop intelligent devices that can perform physical tasks and interact with their surroundings. In the healthcare sector, robotic systems hold the potential to transform numerous areas, including patient care, medical procedures, and overall healthcare operations (Yang *et al.*, 2020).

One of the most significant applications of robotics in healthcare is in surgical procedures. Robotic surgical systems, like the da Vinci Surgical System in Figure 2, allow surgeons to perform minimally invasive surgeries with greater precision and control. These systems feature automated arms with specialized instruments that the surgeon controls, providing enhanced dexterity, 3D display, along with reduced invasiveness. Robotic surgery can therefore result in patients having better surgical outcomes, shorter inpatient care, and faster recuperation periods. Beyond surgery, robots can also support medical professionals with medical care and rehabilitation duties (Ramalingam *et al.*, 2023). They can handle repetitive duties, such as lifting and transferring patients, alleviating bodily strain on healthcare workers and lowering the chance for injuries. Additionally, robotic exoskeletons can help patients recover from injuries or impairments by providing support and assisting them in regaining their strength and mobility.

Robots equipped with sensors and AI algorithms can also be utilized for remote monitoring and telemedicine (Ramalingam *et al.*, 2023). These robots are capable of navigating hospital hallways and patient rooms, collecting vital signs, transmitting data to medical professionals, and facilitating remote consultations. This feature enables medical practitioners to monitor patients in real-time and deliver timely interventions, particularly in remote or underserved regions. Furthermore, robotics can efficiently improve healthcare operations and logistics (Kaplan and Haenlein, 2019). Autonomous robots can be assigned duties including delivering medications, managing inventory, and sterilizing hospital environments. This

automation alleviates the staff working load, enhancing precision, and allowing medical practitioners to dedicate more time to patient care. While robotics in healthcare offers numerous benefits, there are challenges that require attention. It is crucial to guarantee the dependability and safety of robotic systems, particularly during crucial operations. These systems must undergo rigorous testing and validation to satisfy the most stringent safety and efficacy requirements. Additionally, ethical considerations, including patient consent, privacy, and preserving the human touch in healthcare interactions, must be carefully evaluated and managed.

Some notable applications include:

Predictive Analytics

AI models analyze historical data to predict future outcomes. For example, predictive analytics can help identify patients at risk of developing conditions like heart disease, diabetes, or sepsis, allowing healthcare providers to intervene early (Beam *et al.*, 2024).

Clinical Decision Support:

AI-driven decision support systems help clinicians by providing data-driven insights that aid in diagnosing conditions, recommending treatments, and planning surgeries. These systems reduce cognitive overload for healthcare providers and enhance decision-making (Topol, 2019).

Medical Imaging and Diagnostics:

AI algorithms analyze medical images (X-rays, MRIs, CT scans) to detect abnormalities like tumors, fractures, and other diseases. AI models in medical imaging have demonstrated accuracy levels that rival, and sometimes exceed, those of human experts, significantly improving early detection rates (Rajpurkar *et al.*, 2020).

Robotic Surgery and Assistance:

AI-enhanced robotic systems like the **Da Vinci Surgical System** assist surgeons during operations, offering precision in tasks like suturing, cutting, and removing tissue. These systems also monitor patient

vitals and make real-time adjustments to enhance outcomes (Topol, 2019).

3.4. Outcomes of AI Integration in Healthcare

The integration of AI in healthcare has produced significant positive outcomes, such as:

Improved Patient Care:

AI applications improve diagnostic accuracy, personalize treatment plans, and reduce the likelihood of medical errors. AI-powered tools like diagnostic assistants and predictive analytics enable better-targeted treatments, reducing harm and improving patient outcomes (Obermeyer *et al.*, 2019).

Operational Efficiency:

AI can automate administrative tasks, such as scheduling, patient intake, and billing, reducing the burden on staff and improving operational workflows. AI also streamlines hospital management, allowing for more effective allocation of resources and personnel (Beam *et al.*, 2024).

Scalability and Accessibility:

AI-powered telemedicine platforms and diagnostic tools improve healthcare accessibility, especially for underserved populations in remote regions. AI-driven chatbots and virtual assistants can provide 24/7 assistance, helping with routine queries and appointment scheduling (Obermeyer *et al.*, 2019).



4.0 OBSTACLES AND RESTRICTIONS OF AI APPLICATION WITHIN HEALTHCARE

Despite the numerous benefits and potential of Artificial Intelligence within clinical care, there are several obstacles and restrictions as summarized in Table 2, that require attention.

Among the main obstacles is the availability and quality of data, as A.I algorithms require large amounts of high-quality data to learn and make accurate predictions (Chen *et al.*, 2019). However, healthcare data is often fragmented, incomplete, and of variable quality, which can limit the efficiency of A.I-powered systems (Bates *et al.*, 2018). Additionally, there are concerns about insufficient clarity and explainability in decisions made using A.I, which can make it difficult for medical practitioners to comprehend and trust the recommendations made by A.I-powered systems (Obermeyer *et al.*, 2023). Furthermore, A.I application to medical care also raises ethical concerns, like AI algorithms' propensity for bias and the necessity of maintaining patient confidentiality and privacy (He *et al.*, 2019).

The costly price of implementing AI in healthcare remains a major obstacle to its widespread adoption. Developing, deploying, and maintaining AI systems requires substantial financial investment, including expenses for advanced hardware, software, and skilled personnel (Topol, 2019). Additionally, integrating AI into existing healthcare infrastructure often involves costly upgrades and training for staff (Beam *et al.*, 2024). For many healthcare providers, particularly in low-resource settings, these expenses are prohibitive, limiting access to AI-driven innovations. While AI promises to improve diagnostics, treatment, and performance, its high upfront and ongoing costs pose a challenge, especially for smaller institutions (PwC, 2020). Addressing these financial hurdles is critical for enabling equitable utilisation of AI technologies within the healthcare sector.

An additional obstacle to the widespread utilization of A.I within the medical field is the necessity for standardization and regulation, as there is currently no precise rules or regulations for the development and deployment of A.I-powered systems in healthcare (Kumar *et al.*, 2020). This may result in variations in

the performance and safety of A.I-powered systems, which could endanger patients (Sharma *et al.*, 2020). Moreover, integrating A.I-powered systems into existing healthcare infrastructure can be complex and time-consuming, requiring significant investment in IT infrastructure and medical personnel training (Santana *et al.*, 2019). The costly nature of developing and implementing A.I-powered systems is another major obstacle for adoption, particularly for smaller healthcare organizations or those in resource-constrained settings (Liu *et al.*, 2024). According to Rajpurkar *et al.*, (2023), developing safe, effective, and equitable A.I-powered systems would necessitate a collaborative effort in which physicians, researchers, and industry stakeholders work together to address these challenges and limitations.

The constraints posed by A.I in the medical field are also closely tied to the restrictions imposed by the data used to train A.I algorithms, as the quality of A.I-powered systems depends on the quality of the data they are trained on (Gulshan *et al.*, 2016). This means that A.I-powered systems could fail to perform well in situations where the data is limited or biased, such as in rare or underserved populations. Furthermore, AI application in the medical field highlights concerns regarding the function of human clinicians along with the possibility of job displacement, as A.I-powered systems may be able to perform certain tasks more efficiently and accurately than humans (Tucker *et al.*, 2019). According to Wroge *et al.*, (2024), the effective implementation of A.I within the medical field will require a nuanced knowing about the possible perks and limitations of A.I, as well as a commitment to ensuring that A.I-powered systems are designed and deployed with patient safety, equity, and well-being as their top priorities.

5.0 FUTURE POSSIBILITIES OF AI WITHIN THE MEDICAL FIELD

Artificial Intelligence within the medical field has a wide range of intriguing prospects as shown in Figure 3, that could enhance the condition of patients and transform the way healthcare is provided.

Among the most potential applications of A.I within the medical field is the emergence of personalized medicine, where algorithms for A.I can assess health records individually and deliver specific treatment suggestions (Chen *et al.*, 2019). This approach has demonstrated a great deal of potential in enhancing clinical outcomes, especially in fields like oncology and genetics (Liu *et al.*, 2024). Additionally, A.I-powered systems are expected to be crucial in the advancement of clinical precision, which can examine vast volumes of data to pinpoint certain genetic alterations and create customised therapies. According to Rajpurkar *et al.*, (2023), AI applied within the medical field has an opportunity to enhance clinical outcomes, lower cost for medical care, and improve quality of general care.

Another future possibility of A.I within the medical field is the creation of chatbots and robots powered by AI to support medical personnel and help with delivering healthcare (Sharma *et al.*, 2020). These robots and chatbots can help with duties like patient monitoring, medication management, and booking of appointments, freeing up medical personnels to concentrate on extra challenging and high-value tasks (Santana *et al.*, 2019). Furthermore, it is anticipated that A.I-powered systems would be crucial to the growth of telemedicine, as these systems will be able to assess patient records and provide remote consultations and treatment recommendations (Kumar *et al.*, 2020). According to Ramalingam *et al.*, (2023), A.I applied to E-medicine offers an opportunity to increase access to healthcare, particularly in rural and underserved areas. Future developments for A.I within the medical field could also lead to the creation of A.I-powered diagnostic tools that can analyze clinical scans along with patient records to provide accurate and rapid diagnoses (Wroge *et al.*, 2024). This approach has demonstrated tremendous potential in enhancing the

precision of diagnosis while cutting down healthcare costs (Tucker *et al.*, 2019).

A.I's potential in the medical field goes beyond clinical applications to include administrative and operational duties like revenue cycle management, claims processing, and consultation with patients (He *et al.*, 2019). A.I-powered technologies are capable of streamlining these tasks, reducing administrative burdens and improving the general performance of healthcare organizations (Obermeyer *et al.*, 2023). Additionally, A.I-powered systems can assist to uncover areas of waste and inefficiency in healthcare, providing awareness and suggestions for improvement (Gulshan *et al.*, 2016). Overall, AI in the medical field has a wide range of exciting prospects that could transform clinical outcomes and how healthcare is provided.

6.0 CONCLUSION AND RECOMMENDATION

Using artificial intelligence to revolutionise healthcare is a fast-developing domain that has demonstrated enormous potential to improve clinical outcomes, streamline clinical operations, and raise the standard of general care. This comprehensive review has highlighted the existing and emerging AI applications for healthcare, including medical imaging analysis, clinical judgement, predictive analytics, medical engagement, along with personalized medicine. Applying AI to the medical domain has been shown to improve diagnostic accuracy, lower medical cost, as well as improve patient satisfaction. However, there are a number of obstacles and restrictions associated with the use of AI within the medical domain, such as high cost, availability and quality of data, lack of transparency and explainability, lack of technical expertise, and ethical concerns.

To further leverage AI's potential for improving healthcare, the following recommendations are made:

- i. Investment in AI infrastructure: Healthcare organizations should invest in developing and implementing AI infrastructure, including data management systems, analytics platforms, and tools with AI capabilities, to encourage the use of AI within the medical domain.
- ii. Data quality and standardization: Efforts should be made to improve data quality and standardization, including the creation of data standards, data sharing agreements, and data governance policies, to support the utilization of AI within the medical domain.
- iii. Transparency and explainability: AI-powered technologies need to be created to provide transparent and explainable results, including model interpretability and model explainability, to build trust and confidence in decision-making powered by AI.
- iv. Clinical validation and testing: AI-powered systems should be clinically validated and



tested, using controlled clinical trials and observational studies, to demonstrate their safety and effectiveness in reality.

- v. Regulatory frameworks: Regulatory frameworks need to be created and updated for supporting the adoption of AI within the medical domain, including guidelines for AI development, deployment, and use, to ensure health safety and well-being.
- vi. Education and training: Healthcare professionals should receive education and training on the use of AI within the medical domain, including AI literacy, AI ethics, and AI safety, for the efficient implementation of AI in medical settings.

By following these recommendations, medical facilities could harness AI's potential to revolutionize medical care, enhance clinical outcomes, and raise the standard for general care.
