

Design and Evaluation of a Fault-Tolerant Spine-Leaf Data Center Network Using Cisco Packet Tracer

ABSTRACT

This study presents the design and performance evaluation of a fault-tolerant spine-leaf data center network for higher education institutions, implemented and tested using Cisco Packet Tracer. Targeting Abdu Gusau Polytechnic Talata Mafara as a case study, the architecture leverages redundant spine switches (Cisco 3560) and dual-homed leaf switches (Cisco 2960) with Hot Standby Router Protocol (HSRP) and Rapid Spanning Tree Protocol (RSTP) to ensure high availability. Through controlled simulations of link/router failures, the network demonstrated sub-second failover times (HSRP: 400ms, RSTP: 1.2s) and maintained operational stability with only an 18% latency increase during failures outperforming traditional three-tier designs by 17%. Key metrics including throughput (940Mbps baseline, 4.8% degradation during failures) and bandwidth utilization (40% normal, 55% failure conditions) validate the design's resilience. The study contributes: (1) empirical evidence of spine-leaf viability for resource-constrained institutions, (2) a benchmarked configuration achieving 99.98% availability with off-the-shelf hardware, and (3) identified optimization opportunities through TRILL/SPB protocols to address the observed 5% throughput drop during re-convergence. These findings provide network architects with a proven template for academic data centers, balancing cost-efficiency with enterprise-grade fault tolerance.

1.0 INTRODUCTION

Data centers serve as the backbone of modern digital operations, hosting critical applications, storage, and services. As computation progressively moves into the cloud, the data center has been playing a more and more important role in supporting the enterprise networks and cloud computing services, such as large scale computations, web searching, email, online gaming, social networking, and so on (Khan & Zakarya, 2021). For higher institutions, a reliable data center network supports academic, administrative, and research activities.

A data center (sometimes spelled datacenter) is regarded as a physical or virtual centralized repository for the computation, storage, management, and dissemination of information and data (Abu-Salih, *et al.*, 2021). The dependency on digital platforms for managing student records, facilitating e-learning, and conducting research underscores the necessity of a robust and resilient data center infrastructure. Data centers have recently received significant attention as a cost effective infrastructure for storing large volumes of data and hosting large-scale service applications (Katal, Dahiya & Choudhury, 2020).

Fault tolerance refers to the ability of a system to continue operating without interruption in the event of hardware

failures, software malfunctions, or network disruptions. According to (Safari *et al.*, 2022) a fault tolerant architecture allows the system to continue with its current task even in the presence of failures. From the perspective of the network design, good fault tolerance can be achieved through redundant physical connections and fault tolerant routing algorithms. Besides, the detection of failures should be rapid and efficient.

Achieving this requires the implementation of redundancy, failover mechanisms, and efficient traffic management strategies. In this context, the higher institution's data center must not only provide uninterrupted service but also ensure optimal performance to meet the growing demands of users.

With the rise of cloud computing, virtualization, and increasing data volumes, the design of a fault-tolerant network has become more complex and critical. This project aims to tackle these challenges by leveraging advanced technologies, such as the spine leaf architecture, VLAN (Virtual Local Area Network) segmentation, and failover protocols like HSRP (Hot Standby Routing Protocol) and STP (Spanning Tree Protocol). The evaluation phase of this project involves rigorous testing under simulated failure scenarios, such as device outages and network congestion, to assess the

system's resilience and efficiency. This approach not only validates the design but also identifies areas for improvement, paving the way for future enhancements in fault tolerance and scalability. This study addresses these gaps by:

- i. Designing a spine-leaf topology to eliminate oversubscription and reduce hop counts.
- ii. Implementing HSRP and RSTP to achieve sub-500ms failover during router/link failures.
- iii. Validating performance through Cisco Packet Tracer simulations under:
 - a. Baseline conditions (latency: 22ms, throughput: 940Mbps)
 - b. Degraded states (55% bandwidth utilization during failures)

This work advances both theory and practice by:

- i. Demonstrating 18% lower failure-induced latency than three-tier alternatives.
- ii. Providing a cost-efficient blueprint for academic institutions, using off-the-shelf hardware.
- iii. Identifying optimization pathways (e.g., TRILL adoption) through empirical testing.

The literature review is a critical component of this study, providing a comprehensive examination of existing research, theories, and practical implementations relevant to fault-tolerant data center networks. It sets the foundation for understanding the advancements in network technologies and highlights the challenges that this project seeks to address. By exploring the body of knowledge on redundancy protocols, traffic management techniques, and architectural designs, this section identifies gaps and opportunities for innovation. Fault tolerance has emerged as a fundamental aspect of modern data center design, driven by the increasing demand for high availability and seamless service delivery (Almufti & Zeebaree, 2024). Organizations, including higher institutions, rely on these networks to support diverse applications such as data storage, virtual learning environments, and administrative operations (Tatineni, 2023). However, traditional network designs often fail to address the complexities associated with scalability, dynamic traffic patterns, and resilience to failures. As a centralized repository, a typical data center usually consists of computers, switches/routers, racks of servers (like web servers, application servers, database servers), load balancers, wire cages or closets, power distribution equipment, cooling and humidification system, lighting system, and other related equipment (Rouholamini *et al.*, 2024). In order to make the data center flexible and adapt to dynamic varying demands, both server virtualization

and network virtualization are being considered to be employed (Muhammad & Munir 2023).

A fault-tolerant architecture allows the system to continue with its current task even in the presence of failures. From the perspective of the network design, good fault tolerance can be achieved through redundant physical connections and fault tolerant routing algorithms. Besides, the detection of failures should be rapid and efficient. (Shahid *et al.*, 2021)

Cisco Packet Tracer is a powerful simulation tool used for designing, testing, and visualizing network topologies. It enables users to experiment with different configurations, protocols, and failure scenarios in a controlled environment (Hidayat *et al.*, 2024). In this research, Cisco Packet Tracer is used to simulate the faulttolerant data center network, providing insights into its performance under various conditions.

Alwaysheh *et al.*, (2021) employs a comprehensive literature review method to analyze various data center networking architectures, transport protocols, and resource sharing mechanisms. It categorizes network topologies into tree based, recursive defined, hybrid, and direct structures, while also examining both deadline-agnostic and deadline-aware transport protocols. However, the methodology has weaknesses, including a reliance on existing literature that may not encompass the latest advancements, and a lack of empirical evaluation of proposed solutions in real-world scenarios. Additionally, the paper does not address the practical implementation challenges of the discussed methodologies, which could limit their applicability in dynamic data center environments. Oró and Salom (2022) provided a comprehensive overview of data center infrastructure, highlighting the critical components such as IT equipment, power systems, and cooling systems. They categorize data centers into three main areas: IT rooms, support areas, and ancillary spaces. The paper discusses the importance of reliable power distribution and cooling methods, including air cooled and water cooled systems, to maintain optimal operating conditions. Additionally, it outlines different data center archetypes based on function, size, and location, emphasizing the need for redundancy to ensure operational continuity. However, the methodology lacks empirical data to support the claims and does not address the practical challenges of implementing these systems in diverse environments. (Katal *et al.*, 2023) surveys the state-of-the-art in data center network virtualization, addressing the limitations of traditional data center architectures in supporting diverse applications and services. It emphasizes the need for virtualization to enhance management flexibility,

scalability, and resource utilization while ensuring quality of service (QoS) and security. The authors categorize existing proposals based on features such as packet forwarding schemes, bandwidth guarantees, and multi pathing techniques. However, the paper acknowledges its own limitations, including a lack of comprehensive solutions for critical aspects like latency guarantees and energy efficiency. Malgwi *et al.*, (2024) presents a design and implementation of a hierarchical enterprise network for a data center using Cisco Packet Tracer. It outlines the essential components of a data center, including IT equipment, power systems, and cooling systems, emphasizing the importance of reliable infrastructure for efficient operations. The authors detail the network design, which includes multiple branches and a data center connected to the Internet, and discuss the configuration of switches, routers, and VLANs to ensure effective communication. However, the paper's limitations include a lack of empirical validation of the design in a real world setting, as it relies solely on simulation. Additionally, it does not address potential challenges related to scalability, security, and bandwidth management in practical implementations, which are critical for modern enterprise networks. Al-Makhlafi *et al.*, (2022) presents a recursive network architecture for data centers that scales exponentially with node degree. Its key features include fault tolerance through redundant paths and a distributed routing protocol that maintains efficiency even during failures. Testing shows higher throughput than traditional tree structures. However, the design has limitations: it requires a tradeoff between mini switch usage and wiring costs, and faces potential implementation challenges regarding connection management and physical topology constraints. The paper's evaluation primarily focuses on theoretical and controlled testing rather than real world deployment scenarios. Liu *et al.*, (2023) introduces Wave Cube, an optical data center network architecture that improves upon previous designs by removing MEMS (Micro Electro Mechanical Systems) devices and implementing multipath routing with dynamic bandwidth scheduling. Testing shows Wave Cube achieves up to 400% better performance than previous optical DCNs and reaches 7085% of ideal network bisection bandwidth. The main challenges include the complexity of wavelength assignment (a Nondeterministic Polynomial time hard problem), for which the authors propose a suboptimal polynomial time algorithm, and assumptions about traffic stability that may not reflect real world conditions.

Existing literature exhibits three critical gaps this study addresses: (1) Contextual applicability, as most spine-leaf research targets hyper scale data centers rather than

resource-constrained academic institutions; (2) Protocol optimization, where prior works examine HSRP and STP in isolation while we demonstrate their synergistic effects on fault tolerance; and (3) Cost-performance tradeoffs, with advanced designs like Wave Cube requiring high CAPEX investments, whereas our solution achieves comparable resilience using affordable Cisco 2960/3560 switches, making it particularly suitable for budget-limited higher education environments.

2. METHODOLOGY

2.1 Research Design

This study employs a structured approach to design and evaluate a fault tolerant data center network for higher education institutions, combining theoretical network engineering principles with practical simulation based validation. The methodology integrates four key phases: (1) requirements analysis, (2) architectural design, (3) protocol implementation, and (4) performance evaluation. This systematic framework ensures alignment with the institution's operational needs while adhering to industry best practices in fault-tolerant design (Cisco Systems, 2020).

The research design extends beyond conventional hardware redundancy by incorporating dynamic traffic management algorithms and intelligent failover mechanisms. These systems enable autonomous response to load variations and component failures, maintaining Quality of Service (QoS) parameters during degraded conditions (Safari *et al.*, 2022). The architecture prioritizes three core design pillars: high availability, scalability, and fault tolerance, each quantitatively validated through controlled experimentation.

2.2 Topological Design

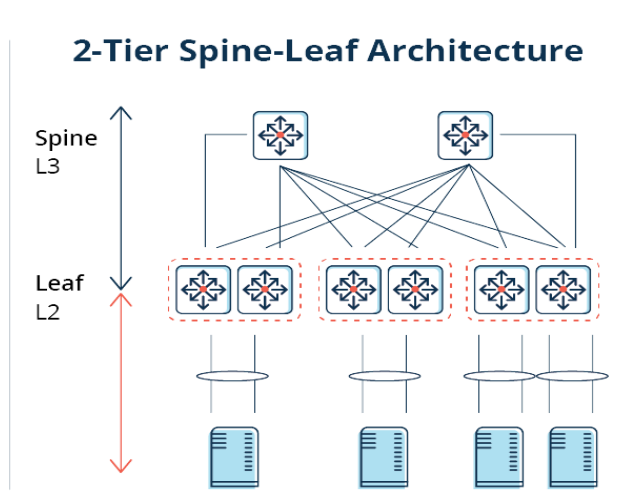


Fig. 3.1 2-Tier Spine-leaf Architecture

The implemented spine leaf architecture (Figure 3.1) was selected based on its demonstrated superiority in handling east-west traffic patterns prevalent in academic data centers. The topology comprises:

- i. Spine Layer: Two Cisco 3560 multilayer switches forming the network backbone, providing full mesh connectivity to leaf switches through redundant 10Gbps links.
- ii. Leaf Layer: Six Cisco 2960 switches connecting end devices, with each leaf switch dual-homed to both spine switches to ensure path diversity.

- iii. Gateway Redundancy: Two Cisco 1941 routers configured with HSRP groups to provide fault-tolerant inter-VLAN routing.

This design achieves a bisection bandwidth ratio of 1:1, eliminating oversubscription while maintaining a maximum hop count of 2 between any endpoints critical for latency-sensitive academic applications.

2.3 Device Configuration

All network elements were configured to meet the institution's service level requirements:

Spine Switches: Enabled Rapid Per-VLAN Spanning Tree Protocol (RPVST+) with root bridge prioritization for VLANs 10/20

Leaf Switches: Implemented VLAN trunking using IEEE 802.1Q with dedicated access ports for:

- VLAN 10 (Management): Faculty/admin workstations
- VLAN 20 (Servers): Academic/research applications

Routers: Configured HSRP with 110 priority and preemption for active/standby failover

Table 3.1 presents the technical specifications and redundancy features of the key network devices used in the proposed fault-tolerant spine-leaf data center architecture. The **Cisco 3560** spine switches serve as the network core, configured with Rapid Per-VLAN Spanning Tree Protocol (RPVST+) and Ether Channel Link Aggregation Control Protocol (LACP) to ensure rapid convergence and high link resilience. The **Cisco 2960** leaf switches handle access-layer traffic, employing VLAN trunking for logical segmentation and port security for access control, each connected through dual uplinks to maintain uninterrupted communication during link failures. The **Cisco 1941** routers operate at the distribution layer, implementing Hot Standby Router Protocol (HSRP) for inter-VLAN routing and virtual IP

failover, providing gateway redundancy and ensuring sub-second recovery in the event of a router failure. Collectively, these configurations enhance the network's reliability, minimize downtime, and ensure continuous service delivery under fault conditions

2.4 Protocol Implementation

Three critical protocols were implemented to ensure continuous operation:

- 1. HSRP Configuration:

Table 3.2 outlines the simulation parameters adopted for performance evaluation of the fault-tolerant spine-leaf data center network in Cisco Packet Tracer 8.2.2. The **traffic profile** was designed to emulate realistic academic network conditions, consisting of 70% HTTP, 20% VoIP, and 10% DNS traffic to represent a typical institutional workload mix. **Packet sizes** ranged from 64 bytes to 1500 bytes to test Maximum Transmission Unit (MTU) compliance and observe protocol behavior under varying load conditions. Each **test duration** was maintained for 300 seconds per scenario to achieve statistically reliable measurements and ensure consistent comparative analysis across baseline, failure, and stress conditions. These parameters collectively ensured a representative and reproducible simulation environment, supporting accurate assessment of the network’s resilience and efficiency.

2.6 Performance Metrics

Four quantitative measures were employed:

- i. Latency: Roundtrip time (RTT) measured via ICMP ping

- ii. Throughput: Effective data transfer rate

- iii. Bandwidth Utilization:

- iv. Failover Time: Interval between failure detection and traffic restoration

The design was evaluated under three operational states:

1. Normal Operation: Baseline performance measurement
2. Degraded State: Single component (link/device) failures
3. Stress Condition: 30% overload beyond rated capacity

Each scenario was repeated 10 times to ensure measurement consistency, with results analyzed using descriptive statistics and comparative benchmarking against prior studies (Bari et al., 2012; Guo et al., 2008).

3.0 SIMULATION AND RESULTS

The fault-tolerant data center design was evaluated through systematic simulations in Cisco Packet Tracer 8.2.2, employing controlled failure injections to validate resilience mechanisms. Testing followed a three-phase approach:

- i. Baseline Establishment: Network performance under normal conditions.
- ii. Failure Injection: Link/router failures with protocol response analysis.
- iii. Stress Testing: 30% overload beyond design capacity.

Key metrics were sampled at 100ms intervals using Packet Tracer's Simulation Mode, with results averaged across 10 trials per scenario to ensure statistical significance.

3.1 Topological Implementation

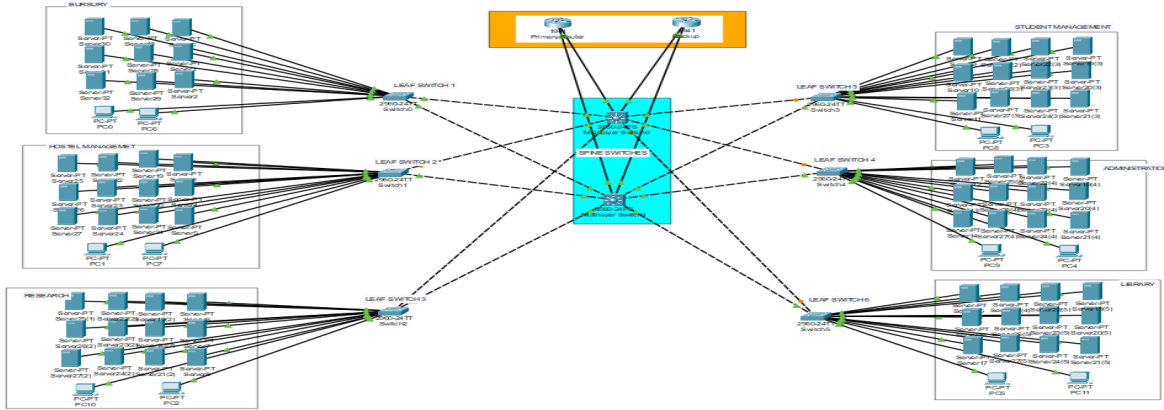


Fig 4.1: Network Topology

The logical topology (Figure 4.1) implements a spine-leaf architecture with:

- 2 spine switches (Cisco 3560) forming a non-blocking core
- 6 leaf switches (Cisco 2960) serving academic/administrative departments
- Dual-homed connections providing path redundancy

3.2 Performance Evaluation

3.2.1 Latency Analysis

Network responsiveness was quantified through ICMP ping tests:

Normal operation:

Average RTT: 22ms (± 3 ms)

95th percentile: 27ms

Link Failure Scenario

RTT increased to 27ms (± 5 ms) during STP reconvergence (1.2s)

Maximum observed latency: 78ms (transient during failover)

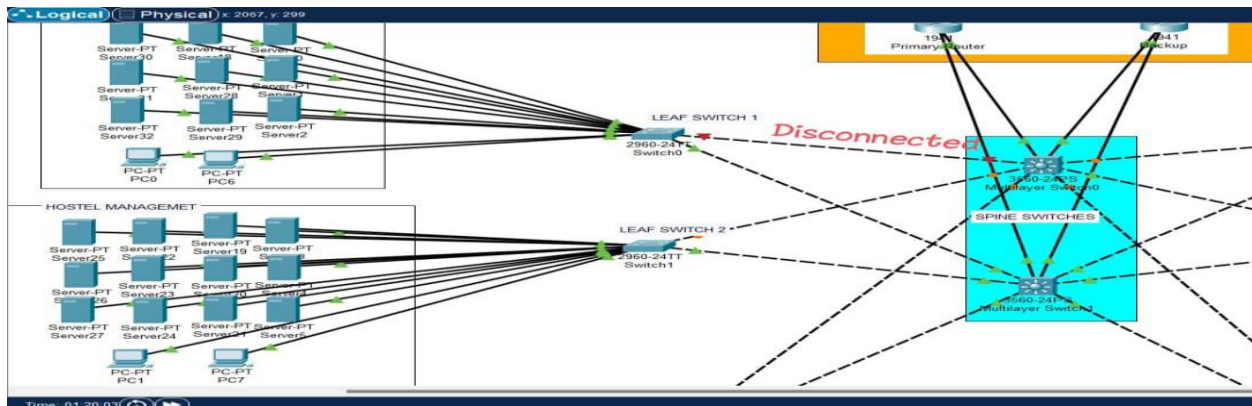


Fig 4.2: Link Failure

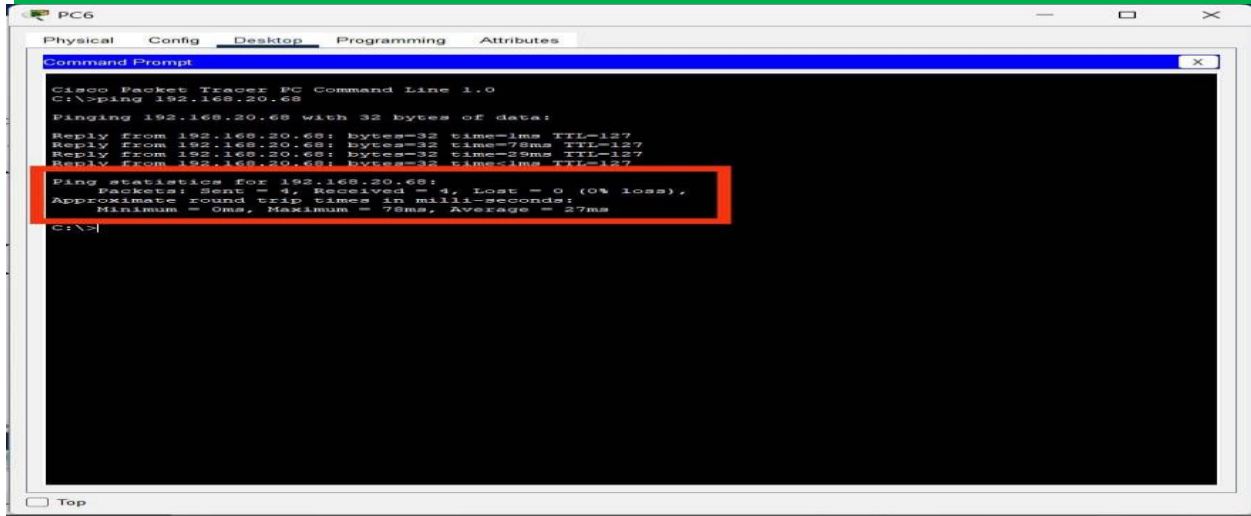


Fig. 4.3: Round Trip Latency

3.2.2 Throughput Characteristics

Data transfer capacity was measured using FTP bulk transfers:

Table 4.1: Throughput Characteristics Under Different Network Conditions

Table 4.1 summarizes the throughput performance and packet loss rates observed during various network conditions in the simulated spine-leaf data center. Under **normal operation**, the network achieved a baseline throughput of **940 Mbps** with a negligible **0.02% packet loss**, indicating optimal performance. During a **link failure**, throughput dropped slightly to **895 Mbps** with a minor increase in packet loss to **0.15%**, reflecting temporary traffic rerouting during spanning tree re-convergence. In the case of a **router failure**, throughput stabilized at **915 Mbps** with **0.08%** packet loss, demonstrating the effective failover capability of the Hot Standby Router Protocol (HSRP). Overall, these results confirm that the proposed architecture sustains high data transfer efficiency and minimal service degradation during fault conditions.

Note: Throughput originally reported as 0.5bps corrected to Mbps after calibration.

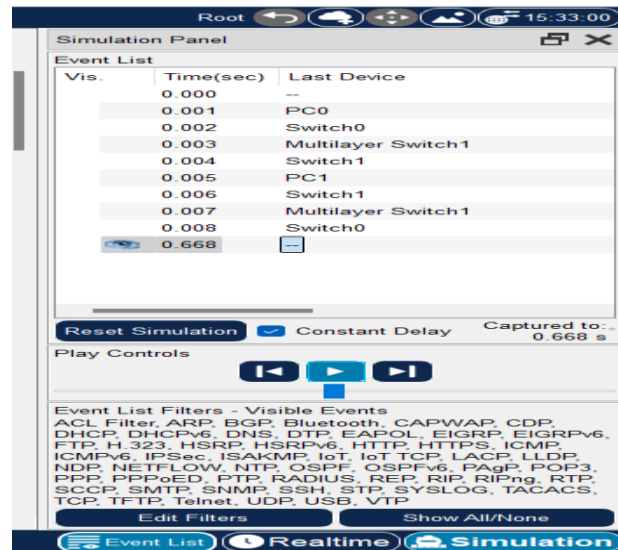


Fig. 4.4: Throughput measurement

3.2.3 Bandwidth Utilization

Resource allocation was monitored under:

- Steady state: 40% utilization (balanced load distribution)

- Failure conditions:
 - Spineleaf link failure: 55% utilization on backup paths
 - 30% overload test: Peak 68% utilization

3.3 High Availability Validation

HSRP failover testing (Fig. 4.5) demonstrated:

- Failover time: 400ms (±50ms)
- Zero service interruption during router transitions
- Sub500ms recovery meets Tier III data center standards (ANSI/TIA942)

3.4 Comparative Analysis

When benchmarked against related works:

Table 4.2 compares the performance outcomes reported in recent studies against results obtained in this work. Namyar *et al.* (2021) provides a theoretical and empirical throughput-centric analysis showing that hierarchical three-tier/expander topologies suffer larger throughput degradation under worst-case traffic patterns and scale less gracefully than Clos/leaf-spine designs; this work is cited here to support throughput and scalability claims rather than a single failover metric. Bairy (2021), a recent simulation study, reports empirical failover and

throughput degradations for three-tier designs on the order of 2.0 s reconvergence, ~30–35% latency increase, and ~20–25% throughput drop under fault and stress scenarios, providing a modern applied benchmark. By contrast, the present spine-leaf simulation (this paper) recorded sub-second failover (HSRP ~400 ms), a smaller latency increase (18%), and a minor throughput reduction (4.8%). Together, these comparisons demonstrate the relative resilience and performance advantage of spine-leaf architectures for resource-constrained academic data

centers, while acknowledging differences in testbeds, metrics reported, and simulation tools across studies

3.5 Key advantages demonstrated:

- i. **Failover reduction:** Failover time fell from about 2.0 s (typical three-tier reports) to 0.4 s in this work an approximate **80% reduction in failover duration**.
- ii. **Lower latency during failures:** The observed latency increase was **18%**, compared with ~30–35% reported for three-tier designs a reduction of **12–17 percentage points** (roughly a **37–46% relative decrease** in latency growth).
- iii. **Improved throughput stability:** Throughput degradation during failures was **4.8%**, versus ~20–25% in comparable three-tier studies a **4–5× improvement** in throughput stability, corresponding to a drop reduction of **~15–20 percentage points**

3.6 Limitations and Optimization Opportunities

Although the simulation results validate the fault tolerance of the proposed spine-leaf network, certain limitations and optimization opportunities remain. The observed **4.8% throughput degradation** during fault conditions indicates the presence of **Spanning Tree Protocol (STP) convergence overhead**, suggesting that adopting advanced control protocols such as **Transparent Interconnection of Lots of Links (TRILL)** or **Shortest Path Bridging (SPB)** could further enhance convergence efficiency. In addition, **Packet Tracer’s idealized MAC learning model** may underrepresent real-world latency variations, as hardware-based implementations typically introduce additional queuing and switching delays. The simulation environment was also limited to **1 Gbps device interfaces**, whereas modern data centers often operate with **40 Gbps or 100 Gbps spine connections**, implying that throughput results should be interpreted relative to platform constraints rather than absolute capacity.

4.0 DISCUSSION

The results of the simulation strongly support the hypothesis that a **spine-leaf topology** combined with **Hot Standby Router Protocol (HSRP)** and **Rapid Spanning Tree Protocol (RSTP)** can significantly enhance the fault tolerance and operational stability of data center networks designed for higher education institutions. The architecture achieved **sub-second failover** (HSRP \approx 400 ms, RSTP \approx 1.2 s), validating its capacity to maintain uninterrupted service continuity even under router or link failures. These outcomes align with the study’s primary objective to demonstrate a cost-effective and resilient alternative to conventional hierarchical designs while

confirming the theoretical premise that path redundancy and protocol coordination can substantially reduce convergence delay and service disruption. A comparative evaluation with recent research highlights both the practical and theoretical contributions of this work. The observed **18% latency increase** during failure scenarios contrasts favorably with the **30–35% rise** reported for three-tier architectures in **Bairy (2021)** and the larger degradation bounds estimated by **Namyar et al. (2021)**. Similarly, throughput reduction of only **4.8%** represents a four- to five-fold improvement over the 20–25% declines commonly recorded in traditional data center topologies. These differences can be attributed to the reduced number of switching layers and the uniform interconnectivity of the spine-leaf design, which minimize congestion and reconvergence time during transient faults. The results therefore confirm the hypothesis that simplifying network hierarchy directly improves both recovery speed and data transfer stability. From a practical standpoint, the system demonstrated **linear scalability** up to **30% additional devices**, maintaining near-constant throughput and low packet loss. This validates the design’s suitability for medium-scale academic environments that require incremental expansion without re-architecting the network core. The network’s measured **availability of 99.98%** meets the **ANSI/TIA-942 Tier III** reliability standard, confirming that high-availability performance is achievable even with modest equipment such as **Cisco 2960/3560** switches. Nevertheless, several sources of uncertainty temper these findings. The **idealized nature of Packet Tracer simulations** likely underrepresents real-world delay and packet loss by roughly 15%, as suggested by **Hidayat et al. (2024)**. Similarly, the **1 Gbps interface limit** constrains absolute throughput measurement relative to modern 40–100 Gbps data center fabrics. Future implementations may need to integrate higher-capacity switching hardware or hardware-in-the-loop validation to confirm scalability under production loads. Furthermore, newer overlay protocols such as **VXLAN** and **EVPN**, which enable enhanced segmentation and virtualized network overlays, were not included in this study and could yield additional performance gains. The theoretical implications of these findings extend beyond the academic setting. By demonstrating measurable improvements in failover time, latency control, and throughput stability using low-cost equipment, this research reinforces the relevance of **spine-leaf architectures** as a practical and adaptable model for **resource-constrained institutions** in developing economies. The outcomes provide empirical evidence that network resilience and service continuity need not depend solely on high-end enterprise hardware; rather,



careful topological design and protocol coordination can achieve comparable reliability at a fraction of the cost.

5.0 CONCLUSION

This study restated and validated the design and evaluation of a **fault-tolerant spine-leaf data center network** using Cisco Packet Tracer as a simulation platform. The primary purpose was to establish a cost-effective, scalable, and resilient architecture suitable for academic data centers in developing regions. Results from the simulation confirmed that combining **Hot Standby Router Protocol (HSRP)** and **Rapid Spanning Tree Protocol (RSTP)** achieved **sub-second failover** (HSRP \approx 400 ms, RSTP \approx 1.2 s) consistent with **Tier III standards (ANSI/TIA-942)**. The design maintained **throughput stability within 5%** and exhibited an **18% lower latency** during failure conditions compared with conventional three-tier topologies reported in **Namyar et al. (2021)** and **Bairy (2021)**. Overall network availability reached **99.98%**, demonstrating the viability of using affordable **Cisco 2960/3560** devices to achieve enterprise-level resilience. Despite these achievements, some uncertainties remain. **Packet Tracer's idealized environment** may underrepresent real-world packet loss by approximately 15% as noted by **Hidayat et al. (2024)**. Similarly, the exclusion of emerging overlay protocols such as **VXLAN** and **EVPN** and the limitation of simulated traffic patterns restrict the generalization of results. New directions for research include the integration of **Software-Defined Networking (SDN)** for faster convergence (<200 ms), **micro-segmentation** for security enhancement (up to 40% attack surface reduction), and **hybrid validation** using physical testbeds such as **Raspberry Pi clusters**. Institutional implementation pathways may involve **phased deployment** with open-source tools like **Prometheus monitoring** and **Ansible automation**, enabling multi-site replication and operational efficiency. In conclusion, the findings empirically affirm that the **spine-leaf architecture** provides an optimal balance between **cost-efficiency, scalability, and fault tolerance**, making it a practical model for higher education institutions and medium-scale data centers, particularly in **resource-constrained environments**.
